Sophia is no stranger to public service, as much of her life's work has involved communication, advocacy, and engagement in the areas of student success and educational access, immigration, economic justice, healthcare, poverty, homelessness, and climate justice. She is the director for equity, diversity, and inclusion for the community and technical college system in Washington state. Sophia was consecrated into the Deaconess Home Missioner order in 2018.


Michelle White

HISTORY OF THE NATIONAL ASSOCIATION OF DEACONESSES, HOME MISSIONERS, AND HOME MISSIONARIES

1988 was the birth year of what is now NADHM, and the birth was both difficult and exciting. At the 1988 General Conference, two decisions, both included in the 1998 *Book of Discipline*, had huge impacts on our community. The category of home missionary was eliminated, although the large number of home missionaries still serving at the time were allowed to retain that relationship to the church. In addition, General Conference allowed Deaconesses, Home Missioners, and Home Missionaries to form an organization similar to that of Church and Community Workers and to retain the existing jurisdictional groups for fellowship.

In August 1988, Deaconesses, Home Missioners, and Home Missionaries – retired and active – gathered in Kansas City at St. Paul School of Theology, formerly National College, for a convocation organized by the Deaconess Program Office with Christine Brewer, Executive Secretary, to celebrate the centennial of deaconess work in the family of United Methodism. There were many folks present who thought that the gathering was a memorial celebration: deaconess numbers had been steadily declining, and, as noted above, there could be no more home missionaries. However, in the midst of celebrating our history and perhaps mourning our demise, the group did organize, and NADAHM (The National Association of Deaconesses, Home Missioners, and Home Missionaries) was born. The very first leadership team was elected with Sybil Dodson as the chairperson and Maureen Carr as the vice-chairperson. The team met briefly at the close of the convocation and began to formulate plans.

However, huge obstacles faced the community with its infant organization. Soon after the convocation ended, three deaconesses were terminated from the General Board of Global Ministries and the Deaconess Program Office was closed. For a time, only the NADAHM Leadership Team and an amazing, generous, determined group, including many retired deaconesses at Brooks Howell, Lay Missioners, etc., were left to support the community. Many letters to the directors of the Board of Global Ministries and frequent, sometimes hostile, discussions with both directors and GBGM staff ensued. Both Sybil and Maureen spent a great deal of time in New York, and with their persistence, GBGM acknowledged that the Deaconess Program Office, which must be administered by a deaconess, is required by the *Discipline*. First Betty Letzig and then Betty Swarthout were assigned as Executive Secretary, Deaconess Program Office.

The first convocation led by NADAHM was in November 1990, at the newly renovated and reopened Scarritt-Bennett Center. From the birth of NADAHM thirty years ago, the community has grown to be active, vibrant, and vital.

NADHM has celebrated the decision of the 1996 General conference to retain the Office of Deaconess and reaffirm the deaconess relationship. In 2004, General Conference voted to establish the office of Home Missioner, and in 2006, we rejoiced in the commissioning of the first two Home Missioners. The Office of Deaconess and Home Missioner under the leadership of Becky Louter worked tirelessly to present legislation at the 2016 General Conference to confirm that Deaconess/Home Missioner is an Order of the UMC. The legislation was officially approved. Today, we are still going strong!





Clara Katrina Abrahamson, 95, died on Friday June 14th, at Treasure Coast Hospice in Fort Pierce, Florida. Clara was born April 17, 1924, in Brooklyn, New York to John and Katri Ellixson. She married Martti William Abrahamson on July 24, 1948, in Brooklyn, New York.

She graduated High School early at the age of 17 and after her husband passed, at the age of 70, Clara successfully completed Master level college courses for the Deaconess program. Clara actively worked as a bookkeeper and office manager in various places. She also volunteered for Treasure Coast Hospice for 5 years doing visitations and working with grieving families. Judy served in various church and community ministries for more than 30 years in rural Tennessee, Memphis Conference; in Polk County,

Arkansas, Little Rock Conference; at the Lake of the Ozarks Parish and Northeast Church and Community Ministry in Springfield, Missouri, Missouri West Conference; and in Twin Valley Parish and Cross-Lines Cooperative Council, Inc., in Kansas East Conference, and Ogden Friendship House in Ogden, KS.

She was active in school, scouting and church activities while growing up in California. She attended three International Federation of Diakonia meetings. In 1993, she traveled to India and Nepal with a mission team to learn about the work of the Methodist church there. Judy served as a director on the General Board of Higher Education and Ministry, Division of Diaconal Ministries, and chaired the World Missions Concerns Committee in the Kansas East Conference. She enjoyed traveling, reading, handwork and sports, among other activities. Judy held a B.A. from Scarritt College in Nashville, Tennessee, and a M.R.E. from Saint Paul School of Theology in Kansas City, Missouri.

Judy also loved dachshunds! She had a beloved dog named Phoebe (after the first deaconess) who died a few years ago.

Gladys Campbell, Deaconess

Gladys Louise Campbell, age 92, was born in Wheat, Tennessee. She graduated from Farragut (TN) High School, and earned a bachelor's degree in Secondary Education at the University of Tennessee (Knoxville). She received a master's degree in Rural Church and Community at Scarritt College for Christian Workers (Nashville, TN); and was awarded a

Doctorate in Humane Letters from Philander Smith (African-American) University (Little Rock, AR).

Following five years as an English teacher in public schools, she became a lay professional worker in The United Methodist Church. She first served in Carter County (TN) and Pitman Center (near Gatlinburg, TN). Then she became Associate Director of Hinton Rural Life Center (located in Hayesville, NC) and served in church leadership development across the Southeastern Jurisdiction and beyond. For her last 27 years of service, Gladys was based in New York City with the General Board of Global Ministries. As Director of Town and Country Ministries, she served communities across the USA and at times in other countries.

A passion in her ministry was working with all levels of church and community leadership in developing cooperative parishes (United Methodist and ecumenical) among churches in given geographic areas in town and rural settings. Her mantra was doing together the things that could be accomplished better together than working alone.

Gladys was known for her generosity in providing funds and personal encouragement for young people inspiring to seek training for life's vocation(s). Her generosity also overflowed in countless ways with family members and extended families in their life-long journeys.

Kay F. Collins, age 80, died Sunday, January 22, 2023, at her friends Mark and Jina Ballard's home, where she had been living and cared for. Born April 3, 1942 to John and Lucille (Kersey) Collins. She was

raised in Milledgeville, Georgia. Kay attended Young Harris College in

Young Harr, GA., Scarritt College in Nashville, TN, and then St. Paul School of Theology in Kansas City, MO. She graduated with a Masters Degree in Theology. After graduation, she went to Alabama, serving 7 years as a church and community worker for the Board of Missions for the United Methodist Church.

Kay began in 1974 as the Chaplain of Silver Cross Hospital in Joliet, IL and continued working through the building of the new Silver Cross Hospital in New Lenox, IL. She was the Chaplain of the hospital for 40 years, retiring in 2014. She also volunteered for Childerguild and Encore Shop at Silver Cross Hospital during and after she retired.

Buford, of Bastrop, TX, obtained his PhD from the University of Texas in Austin in Sociology and Social Work in 1973. He also attended UT Austin for his undergraduate degree from 1942-1949, and he obtained a master's degree in social work from University of Tennessee. He served as a professor of sociology and social work. He was 98.



Mildred Garcia, Deaconess March 19, 2021

Mildred Garcia worked for many years in and retired from the Records Department at the General Board of Global Ministries. She was active in the deaconess community and for many years attended Convocation, which she generally rode the Greyhound Bus to!

Mildred, who was from Puerto Rico, lived in the Bronx but spent a lot of time after retirement at her daughter's home in Carmel, NY - approximately one hour from New York City. Her daughter was married to a New York City Firefighter, and they had one son.

Mildred was loved by many and very close to her fellow deaconesses who worked together with her at GBGM.



Pamela Johnson, Deaconess March 20, 2024

Pam was consecrated as a deaconess on April 27, 2014, in Louisville, KY at the United Methodist Women's Assembly. She was a member of Aitkin United Methodist Church where she lived in Aikin, MN. Pam was an active deaconess, serving at Oakridge Homes as a Lead Life Skills Trainer. In her ministry, Pam worked with individuals with developmental

disabilities. She was an advocate for people with disabilities in her ministry as she worked with families and throughout the community. She was also a coach for the Special Olympics. Pam was active with United Women in Faith. Last year, she held the position of education and interpretation. She supported the work of Racial Justice in all aspects - through her position with UWFaith, in her church, in her personal life, and in her appointment. In addition to her ministry appointment, Pam served as pulpit supply for area churches on a monthly basis, and she was an active lay leader for the Minnesota Conference.



Esther Megill, Deaconess August 26, 2023

Esther Megill died peacefully Saturday August 26, 2023. She was the oldest and only girl of six children. At nearly 100 years old, she outlived them all! Esther grew up in the United Brethren in Christ Church, which later became the Evangelical United Brethren Church, where both her parents were ordained ministers.

Esther's early years were spent in a number of small towns, as her parents were moved from one charge to another, mostly in the Kansas Conference. In 1942,

she entered York College, the U.B. college in York, Nebraska (united with Westmar College, LeMars, Iowa, after church union to form the Evangelical United Brethren Church in 1946), and graduated summa cum laude with a Bachelor of Science degree in 1946. During the next four years, she taught high school science and English for one year in St. Edward, Nebraska, and served for three years in Dayton, OH as the director of the Central Girls Club. She then entered the School of Medical Technology at Miami Valley Hospital in Dayton and became a registered medical technologist.

On June 1, 1950, Esther was commissioned as a missionary of the Evangelical United Brethren Church. After four months of study in England, she went to Sierra Leone, West Africa, arriving in January 1951. There she served as a medical technologist at the hospital in Rotifunk until June of 1962. She also worked with the local church and conference as a Christian educator.

During furloughs, she studied at Hartford Seminary Foundation in Hartford, CT and graduated with a Master of Arts in Religious Education in 1960 and a Doctor of Religious Education in 1966. Following graduation, she worked at McCurdy School in New Mexico developing a curriculum for teaching religion in the high school. After the church union in 1968, she went to New York as an Executive Secretary for North and West Africa.

In 1972-73, she took further postgraduate work at the University of Tennessee, Knoxville, then went to Ghana, where she served for seven years as teacher of religious education at Trinity College, Legon, and Director of Department of Church Leadership (until 1980). Two years following she worked as Mission Interpreter in Residence for the Southeast Jurisdiction. Then, in 1982, she went to Wood Junior College, Mathiston, Mississippi, to establish and develop the Center for Church Leadership Development, a program of leadership development in small membership churches. In September of 1983, she transferred to the National Division and became a deaconess.

Esther was an educator, author, illustrator, photographer, theologian, missionary, and more! Following retirement in 1989, she went to Africa for a year's volunteer work with churches in five countries. After travel, she returned to Mississippi, and moved to Brooks-Howell Home in Asheville, NC on January 10, 1991, where she became a member of Biltmore United Methodist Church. At Brooks-Howell, she loved singing in the choir, and she was a staunch defender of LGBTQ rights. She had a sign on her door that said: "Homophobia is so old church."



Edwin E. Odom, Home Missionary March 3, 2020

Edwin Earl Odom, 90, of Webster Groves, MO, died peacefully at St. Luke's Hospital on Tuesday, March 3, 2020. He was born on June 10, 1929, in Vinson, OK, to the late James Frank and Clara Brown Odom. He moved to LaVerne, CA, in his teens, where he met and married his late wife Toy

Mae Weddle.

Ed and Toy began their married life as house parents at David & Margaret Youth and Family Services in LaVerne, CA, where they nurtured life-long friendships with the young people who lived there. This was also the beginning of Ed's long career ministering to children and youth who suffered abuse, loss, and trauma. He dedicated his working life to the Methodist Church and its mission to serve children in foster care by leading child welfare institutions across the country, including Cunningham Children's Home in Urbana, IL, and Epworth Children and Family Services in Webster Groves. He retired from Epworth in 1994. Over the years, Ed and Toy welcomed dozens of young people into their hearts and lives, standing in as surrogate parents and chosen family for them.

Toy died in July 2007. Ed also spent his retirement in service to others, first in caring for his wife Toy through her final illness, and then by volunteering thousands of hours to his faith community and to supporting other faith-based human service organizations in the Greater St. Louis area including LifeWise STL (formerly Kingdom House), Lessie Bates Davis Neighborhood House, and Great Circle (formerly Edgewood Children's Center.) He was one of the moving forces behind the founding of the interfaith Shepherd's Center in St. Louis, which helps older adults remain engaged in the community. He was a keen athlete, an avid gardener, and an adventurous cook.

Ed was known for his elaborate flower beds and decorative planters, a hobby he continued even after moving into LaClede Groves retirement community, where he worked to beautify the buildings and grounds with his colorful plantings.

Rosalina came to the US in 1980 as a Crusade scholar and graduated from Vanderbilt University in 1982. She became an affiliate member of on she was at Vanderbilt

Belmont UMC when she was at Vanderbilt.

In 1980, Rosalina became the first deaconess to transfer her relationship from the Philippines to the United States. She served in many capacities both in the Philippines and US, including as the Superintendent of Knox School Inc. in Manilla, Philippians, and as a beloved teacher at the Forest Heights Pre School in Jackson, TN. She held a Master's Degree in Administration and Supervision from the Christian University of Manilla and completed her doctoral studies in Early Childhood Education at Vanderbilt University.

Rosalina was an active member of Forest Heights United Methodist Church. She served in leadership roles in The United Methodist Women both on the local and Conference levels. More than anything else, Rosalina was a compassionate person who never met a stranger. Her deep faith in Jesus Christ anchored her during times of trouble and times of joy. She had a close relationship with her sister, Ida, with whom she shared a home. Whenever you saw Rosalina, Ida would be standing next to her, hand in hand. Rosalina was a tiny woman (standing only 4'7") with a HUGE heart. She will be deeply missed.

Resolution to Create a Task Force for the Development of a Scholarship Fund

Whereas the National Association of Deaconesses and Home Missioners (NADHM) recognizes the importance of participation in key events such as NADHM Convocation, Annual Conference, Diakonia of The Americas and Caribbean (DOTAC), World Federation of Diakonia, and other similar gatherings for the spiritual growth, professional development, and networking of its members;

Whereas such participation often requires financial resources that may be beyond the means of some members, thereby limiting their opportunities to engage fully in these valuable events;

Whereas the NADHM desires to support its members in overcoming these financial barriers and ensuring equitable access to such important events;

Be it resolved that a Task Force be established to review, plan, and develop a proposal for the creation of a Scholarship Fund dedicated to assist with registration fees and other related expenses for NADHM members to attend Convocation, Annual Conference, Diakonia of The Americas and Caribbean, World Federation of Diakonia, and similar events.

Be it further resolved that the Task Force shall consist of representatives from the NADHM Board and deaconesses and home missioners who are members of NADHM in good standing¹ and representing a span of years of service.

Be it further resolved that the Task Force shall:

- 1. **Review:** Conduct a thorough review of existing scholarship programs and best practices for fund administration in similar organizations.
- 2. **Plan:** Develop a comprehensive plan outlining the structure, funding sources, eligibility criteria, application process, and distribution mechanisms for the proposed Scholarship Fund.
- 3. **Recommend:** Provide recommendations for the implementation of the Scholarship Fund, including an initial budget, potential fund-raising strategies, and ongoing management.
- 4. **Report:** Present its findings and recommendations to the NADHM Board for approval and recommendation to the membership at the 2026 NADHM Convocation or a duly called virtual session.

Be it further resolved that the NADHM Board shall support the Task Force by providing necessary resources, including administrative support and access to financial records as needed, to facilitate the successful development and launch of the Scholarship Fund.

Be it finally resolved that the NADHM Board shall review and evaluate the effectiveness of the Scholarship Fund on an annual basis to ensure it meets the needs of its members and adjust policies as necessary to enhance its impact.

BYLAWS OF THE NATIONAL ASSOCIATION OF DEACONESSES, HOME MISSIONERS, AND HOME MISSIONARIES OF THE UNITED METHODIST CHURCH

ARTICLE 1: AUTHORIZATION

The Association is authorized under the current United Methodist Book of Discipline.

ARTICLE 2: NAME

The name of this Association shall be the National Association of Deaconesses, Home Missioners and Home Missionaries of The United Methodist Church (NADHM).

ARTICLE 3: PURPOSE

The purposes of this Association are to:

- provide an independent voice for United Methodist Deaconesses, Home Missioners and Home Missionaries both within The United Methodist Church structure and in the larger society;
- provide various programs, support, resources and activities that enable the development of a sense of community among its members;
- and further the ability of commissioned/consecrated workers to carry out their ministries of service and social justice.

All of these purposes are seen as celebrating the love of Jesus Christ and the arrival of the Kingdom of God in the midst of a troubled world.

ARTICLE 4: MEMBERSHIP

- A. Membership in the Association shall be open to all individuals who are commissioned/consecrated and in current relationship (active and retired) as deaconess, home missioner, or home missionary by the United Methodist Women national organization (UMW) of The United Methodist Church (UMC). Our membership is open to all regardless of the following: age, race, family status, gender, gender identity, sexual orientation, ethnicity, disability, and status (retired and active).
 - a. To be a member you must pay your annual dues and remain current. To remain current means that the individual has paid dues in the current year and the previous year. Individuals who join the Association for the first time are not required to pay dues for the previous year, but are required to pay dues for the current year to be a member.
 - b. Members have voice and vote in business meetings of the Association.
 - c. Members are eligible to serve on the Leadership Team and apply for various scholarships and grants.
- B. Individuals such as candidates and fellow United Methodists who are interested in the activities of deaconesses, home missioners, and home missionaries may become associate members of the Association.
 - a. To be an associate member you must pay your annual dues and remain current.
 - Associate members have voice but <u>not vote</u> at association business meetings. Associate members <u>are not eligible</u> to be members of the Association's Leadership Team.
 - c. Associate membership may be limited by the Leadership Team.
- C. The Association shall have the authority to set and collect dues from all members and associate members.

ARTICLE 5: LEADERSHIP TEAM

The affairs of the Association shall be led by a Leadership Team which consists of the following elected members to ensure inclusiveness as defined in Item 10 of the Standing Rules.

- A. **The Chairperson** shall be the chief executive officer of the Association and shall preside at all meetings of the **Association** Leadership Team. The Chairperson shall manage Association business in accord with the actions of the Leadership Team and perform other duties as defined by the Leadership Team in the Standing Rules.
- B. **The Vice-Chairperson** shall perform the duties of the Chairperson in his/her absence and perform other duties as defined by the Leadership Team in the Standing Rules.
- C. **The Secretary** shall take minutes of all meetings of the Leadership Team and Association business meetings. The Secretary shall distribute copies of Leadership Team minutes to the Team within one month of the meeting. Copies of Association business meeting minutes shall be distributed to the Association members with the notice of the next business meeting. The Secretary shall perform other duties as defined by the Leadership Team in the Standing Rules.
- D. The Treasurer shall have care and custody of the Association funds and shall disburse the funds of the Association as ordered by the Leadership Team; shall keep full and accurate records of receipts and disbursements in books belonging to the Association; and shall deposit all money of the Association in accounts designated by the Leadership Team. The Treasurer shall present financial reports at each Leadership Team and Association business meeting. The Treasurer shall arrange for a biennial review of Association books and perform other duties as defined by the Leadership Team in the Standing Rules.
- E. **At Large** team members may be selected by the Leadership Team to ensure inclusiveness as defined in Item 10 of the Standing Rules or to include additional competencies to balance the needs of the Leadership Team. The total membership of the Leadership Team shall be no less than 5 and no more than 12.
- F. **Executive Secretary(ies)** of the administrative office for the Offices of Deaconess, Home Missioner, and Home Missionary of United Methodist Women national organization shall serve as ex-officio member(s) of the Leadership Team with voice but not vote.

There shall be **additional officers** appropriate to the needs of the Association and as defined in Item 10 of the Standing Rules. The needs shall be reviewed by the Leadership Team during each biennium giving sufficient time for the Nominating Committee to recruit candidates for the office prior to the next Association Business Meeting.

ARTICLE 6: MEETINGS

- A. There shall be a business meeting of **the Association** at least once every two years at a time and place designated by the Leadership Team. Written notice of these meetings, designating time and place, shall be sent to members at least 30 days before the day set for the meeting. Any business of the association may be transacted at any of these meetings whether or not such business has been specified in the notice of the meeting, unless specific notice of such business is required by the bylaws or by law.
- B. Special meetings of the Association may be called by the Chairperson
 - a. at times he/she deems necessary;
 - b. at the request of the Leadership Team; or
 - c. at the request of 25 percent or more members of the Association.

Written notice of any special meetings for item B.c, designating time and place, shall be sent to all members in writing at least 30 days before the date set for the meeting.

- C. The presence of any member at the meeting shall constitute waiver of notice by that person.
- D. Each active and retired members present at a business meeting shall be entitled to one vote. There shall not be proxy votes of members not present at meetings.
- E. Transaction of business shall require a quorum of members, a quorum being defined as 10 percent or more of the members of the Association. The parliamentary authority for business is the current edition of *Robert's Rules of Order*. Resolutions should be submitted to the Vice Chairperson at least three months before the business meetings, so that the resolutions can be sent out to members at least 30 days before the business meetings.
- F. There shall be a minimum of one meeting per year of the Leadership Team. Notification of each meeting shall be sent to members in writing at least 30 days before the meeting. These meetings may be conducted with all team members in one location or via conference call or other method of meeting in which all team members can participate.
- G. Special meetings of the Leadership Team may be called by the Chairperson when deemed necessary and shall be called by the Chairperson when requested by three or more members of the Leadership Team.
- H. All meetings of the Leadership Team shall be held at a time and place and in a format determined by team members. Members of the Leadership Team shall be reimbursed for reasonable expenses incurred in the performance of their duties, including costs of attending meetings.
- I. At all meetings of the Leadership Team, a simple majority of team members may transact business.
- J. The Leadership Team shall write, approve and implement Standing Rules for the Association. Changes to the Standing Rules must be approved by a simple majority of the Leadership Team members.

ARTICLE 7: NOMINATIONS AND ELECTIONS, TENURE OF OFFICE

- A. There shall be a Nominating Committee comprised of seven members of the Association who shall be elected by members of the Association at the biennial business meeting. Nominating Committee members shall be elected to four-year terms. Approximately half of the Nominating Committee shall be elected every two years to ensure continuity. One member of the Leadership Team, as determined by the Standing Rules, will serve as the chairperson of the Nominating Committee. In so far as practical, the Nominating Committee shall be inclusive considering factors identified in the Standing Rules.
- B. The Nominating Committee shall prepare a slate of nominees for each biennial Association business meeting. The slate shall have one nominee for each open office and Nominating Committee position. If the Nominating Committee feels it is appropriate, they can nominate two members to serve together for a particular office. In so far as practical, the slate shall be inclusive considering factors identified in the Standing Rules. The proposed slate shall be distributed in writing with the notice of the biennial meeting at least 30 days prior to the meeting. Additional nominations can be made from the floor of the business meetings. The person must be eligible to serve, have been asked previously, shown the job duties, able to fulfill the duties and agree to serve.

- C. Officers shall be elected by members of the Association during the biennial business meeting of the Association.
- D. If an office becomes vacant by reason of death, resignation, removal from office, or otherwise, the vacancy shall be filled by the Leadership Team. Individuals appointed to fill such vacancies shall hold office until the next election. Individuals filling such vacancies may be nominated and elected to a full four-year term at the next election.
- E. Officers shall be elected to four-year terms. Approximately half of the officers shall be elected every two years to ensure continuity on the Leadership Team. Individuals may serve up to two consecutive four-year terms. After serving two consecutive terms, an individual will not be eligible to serve on leadership for four years. After four years, the individual could be elected to serve on the leadership team again. The one exception is that a present Leadership Team member who has not served as Chairperson may be nominated and elected as Chairperson for up to two four-year terms.
- F. The effective date of each term of office will be January 1 following the election.
- G. Any officer may be removed by a majority vote of the Leadership Team at any time with cause, such as **failure to fulfill responsibilities**, lack of attendance or lack of participation in meetings.

ARTICLE 8: MISCELLANEOUS

- A. The fiscal year of the Association shall be the calendar year.
- B. The principle office of the Association shall be at the location of the Treasurer.
- C. The Association exists in conformity with *The Book of Discipline of the United Methodist Church* and has liaison with the United Methodist Women national office through the Executive Secretary of the administrative office for the Offices of Deaconess, Home Missioner, and Home Missionary of United Methodist Women national organization.
- D. The Leadership Team shall have full power to determine the amounts and conditions to be attached to scholarships and grants of funds of the Association, and to determine who shall be the recipients with the exception of grants from the Compassion Fund.
- E. The Association Chairperson and a second designated member of the Leadership Team shall have full power to determine granting of funds from the Compassion Fund. When such grants are made, the Chairperson must notify Leadership Team members that a grant has been made and the amount of the grant but not the name of the person receiving the grant. Compassion Fund grant amounts must be within dollar amounts set in the Association's Standing Rules. Leadership Team members can approve higher amounts than designated in the Standing Rules when they deem a need requires additional funds. All Compassion Fund grants are to be kept confidential. Only the two Leadership Team members involved in the selection and the recipient are to know details of the Compassion Fund grants.
- F. The Leadership Team shall not take any action that is not within the corporate powers and purposes of the Association or that will have the effect of impairing or destroying the tax exempt status of the Association under federal or state statutes granting such exempt status. (NADHM is included as an "affiliated organization" in The United Methodist Church Group Tax Exemption ruling.)

- G. To amend these bylaws, written notification, including proposed changes in these bylaws, is to be distributed to all voting members of the Association at least 30 days in advance of a duly called meeting. These bylaws may be amended by members of the Association by a twothirds vote of those voting members present and voting at a preannounced meeting of the Association members.
- H. All bylaw considerations and recommendations from the members must be studied and adopted by the Leadership Team for an official vote of all voting members at a duly called meeting.

STANDING RULES of the National Association of Deaconesses, Home Missioners, and Home Missionaries (NADHM)

Bylaws Article 6:J gives the authority regarding Standing Rules to the Leadership Team. These are being shared with the Association for information purposes but no action is required on the part of the association.

1. Authorization

The Association is authorized under the *United Methodist Book of Discipline*, Article 1317.2 (2012). *There may be a national organization of deaconesses, home missioners, and home missionaries in relationship with United Methodist Women.*

2. Dues

- a. Dues active-service members: Annual \$40
- b. Dues for retired members: Annual \$25
- c. Dues for associate members: Annual \$25
- d. Annual dues will cover operation costs of the Association, including some convocation expenses.
- e. The Treasurer of the Association will send members' dues notices at the beginning of each calendar year.
- f. Starting September 1, 2017, to qualify for the 2 years prepay discount, payment must be received by December 31 of the first year.
- g. Starting September 1, 2017, the requirement to fully pay annual dues in order to register and attend the convocation is waived. However, in order for active-service members and retired members to receive a scholarship to attend the convocations and annual conferences, they must be in "good standing" as determined by NADHM.
- h. Starting on January 1, 2018, dues for retired members will be reduced to the same rates as associate members.

3. Convocation

A Convocation shall be held once every two years at a time and place decided by the Association's Leadership Team. All members of our order are welcome to attend the convocation.

4. Relationship between the Association and the United Methodist Women national organization (UMW).

- a. The Chairperson of the Association serves as a member of the Committee on Deaconess and Home Missioner Service.
 - i. The Association pays the Chairperson's costs for transportation to committee meetings.
 - ii. The administrative office for the Offices of Deaconess, Home Missioner and Home Missionary of UMW pays room, board, and other costs at the meetings.
- b. The Executive Secretar(ies) of the administrative office for the Offices of Deaconess, Home Missioner, and Home Missionary of UMW serves as an ex-officio member of the Association's Leadership Team.
 - i. The administrative office pays the Executive Secretar(ies') costs for transportation to Leadership Team meetings.

ii. The Association pays room, board, and other costs at the meetings.

5. Financial Accounts

The names of the Association Chairperson and Treasurer shall be on all of the Association's accounts. Investments shall be consistent with United Methodist Social Principles.

6. Compassion Fund

Compassion Fund grants can be made to members in good standing by the Association Chairperson and designee in amounts up to \$1,000. Grants for larger amounts must be approved by a simple majority of Leadership Team members. Voting may be done by e-mail or voice vote on conference calls.

Criteria:

- I. Active and retired commissioned/consecrated Deaconesses, Home Missionaries, Home Missioners who are members of NADHM are eligible.
- II. Written inquiries made to NADHM Chair.
- III. Dollar amount annually is \$1,000 as a maximum.
- IV. A person cannot receive more than \$2,000 within a 5-year period.

7. Leadership Team Job Duties

Duties of Leadership Team Officers, in addition to those stated in the Bylaws, shall include but not be limited to the following. The allocation of responsibilities may be changed based on the skills and interests of the members. Leadership Team members should maintain digital and/or written records and files related to their position to incoming officers. They also have the responsibility to submit their records and files to incoming officers. The Vice Chair shall be responsible to ensure all records are submitted to incoming position officers by January 31 of the following year. All members must submit annual records and files to the Secretary by January 1 of the following year. The Secretary shall provide copies of said records and files to the Chair and Vice Chair.

Chairperson

- Enable and support team members to fulfill their roles and oversee the details
- Notify Leadership Team of the times and arrangements for team meetings
- Coordinate and co-chair planning and operations of the convocation and business meeting
- Coordinate convocation site and contract
- Represent the association at meetings of and with other mission-worker associations and church organizations such as the UM Missionary Associations and Church and Community Workers' Organization, UM Deacon, Ecumenical Groups
- Represent the association at meetings such as the Committee on Deaconess/Home Missioner Service, National Organization of UMW Program Advisory Group and Board, and Administrative Office Staff/Consultant meetings
- Represent the association in new ventures for the good of the community
- Attend and serve as an alternate voting member of DIAKONIA of the Americas and Caribbean (DOTAC) and DIAKONIA World Federation
- Approve Compassion Fund and annual conference scholarship requests in consultation with one other Team member
- Coordinate and consult with the Administrative Office
- Be available to the community, listen to and then represent concerns of its members

- Mediate between members of the community and the administrative office on issues of concern
- Participate in preparation and training of Candidates and Consecration service
- Convene and chair special ad hoc sub-committees, as necessary to promote NADHM's mission such as NADHM website development and implementation, membership drives, and other special programs
- Approve all NADHM webpage content
- Delegate responsibilities as necessary

Vice-Chairperson

- Chair the Nominating Committee.
- Coordinate updating of bylaws, standing rules and articles of incorporation.
- Oversee procedures and submissions of resolutions to business meetings of the association.
- Oversee quadrennial elections of community representative to the UMW Program Advisory Group and Committee on Deaconess/Home Missioner Service.
- Prepare ballot for elections, including statements and photos from nominees.
- Maintain historical list of officers and terms.
- Coordinate membership drives with Leadership Team.
- Coordinate records management and records transfer processes.
- Coordinate and co-chair planning and operations of the convocation and business meeting.
- Serve as a member of any special ad hoc sub-committees.
- Coordinate other leadership assignments as delegated by the Chairperson.

Secretary

- Work with other officers to fulfill their responsibilities as needed
- Help with registration and nametags at convocation.
- Maintain digital copy of meeting minutes and ensure a hard-copy of records of meeting minutes are sent to Brooks-Howell.

Treasurer

- The Treasurer of the Association will send an annual membership dues letter to all members of the deaconess, home missioner, and home missionary community and associate members of the Association and receive dues payments.
- Send membership cards to all members who pay dues.
- Maintain the Association membership list and provide it in electronic or printed form for mailings by other Leadership Team members.
- Record membership dues on data base.
- Facilitate developing an annual and convocation budget.
- Process convocation registration payments and monetary gifts.
- Pay any Association bills, including travel expenditures
- Record and coordinate any monetary gifts received on the behalf of NADHM
- Send gift acknowledgments for gifts to Compassion Fund or to the Association, that names giver and person honored or memorialized
- Help with registration on site at Convocation
- Send end-of-year statements for tax purposes when requested
- Track PayPal payments and online registration for Convocation
- Responsible for having persons to count funds collected at Convocation and verify amounts collected

- I. Facilitator of Convocation Program/Technology
 - Enable the work of the Leadership Team in areas of technology
 - Help research and secure online registration program for Convocation
 - See that presentation material is prepared for Convocation (power point, etc.)
 - Ensure needed media resources and technology will be in place for Convocation, including live streaming
 - Set up, run, and troubleshoot on site technology at Convocation. Enlist assistants to run media on site
 - Secure and run conference call system for Leadership Team and Nominating Committee calls
 - Set up and sustain online group for Leadership Team work and separate one for
 - Community members to have dialogue and coordinate with Facilitator of Communication
 - Work with Communication Consultant of Administrative Office and Facilitator of Communication on design and functionality of NADHM website
 - Expand social media presence of NADHM and coordinate with Facilitator of Communication
 - Explore the use of cloud technology for NADHM and coordinate with Facilitator of Communication
 - Facilitate discussion and selection of the Convocation theme
 - Coordinate the Convocation program, including logistics with the site, workshops, speakers, musicians, and fellowship times
 - Work with Facilitator of Spiritual Growth and musicians to plan convocation worship services
 - Compile and format convocation program book
 - Assist with NADHM membership drives

II. Facilitator of Communication

- Interpret and promote the Association's purpose, opportunities, and benefits to members of the wider deaconess, home missioner, and home missionary community to members and to those who have not joined the Association.
- Write articles, approved by Chair, to submit to the Communication Consultant of Administrative Office promoting Convocation, membership drives, and notices to the community.
- Facilitate social media communication between the leadership team, Communication Consultant, and NADHM members.
- Expand social media presence of NADHM and coordinate with Facilitator of Convocation Program/Technology.
- Explore the use of cloud technology for NADHM and coordinate with Facilitator of Convocation Program/Technology.
- Sustain NADHM website.
- Assist the Facilitator of Convocation Program/Technology to ensure needed media resources and technology will be in place for Convocation, including live streaming.
- Assist the Facilitator of Convocation Program/Technology to set up, run and troubleshoot on site technology at Convocation.

III. Facilitator of Convocation Program

- Facilitate discussion and selection of the Convocation theme.
- Coordinate the Convocation program, including logistics with the site, workshops, speakers, musicians, and fellowship times.
- Work with Facilitator of Spiritual Growth and musicians to plan convocation worship services.
- Create convocation evaluation form and compile convocation evaluations.
- Compile and format convocation program book.
- Work with Facilitator of Convocation Program/Technology for program/ppt. slides content at convocation.
- Assist with NADHM membership drives.

IV. Facilitator of Spiritual Growth - Outreach

- Provide spiritual leadership for the Leadership Team
- Prepare a Convocation devotional resource; plan convocation worship services, including memorial service, devotionals, morning prayers, prayer and meditation room, and spiritual growth activities working with the Facilitators of Program
- Recommend spiritual growth resources and experiences to members of the Association.
- Assist with NADHM membership drives and outreach efforts.

V. Facilitator of Spiritual Growth - Convocation Special Events and Programs

- Provide spiritual leadership for the Leadership Team
- Prepare a Convocation devotional resource; plan convocation worship services, including memorial service, devotionals, morning prayers, prayer and meditation room, and spiritual growth activities working with the Facilitators of Program
- Lead NADHM membership ministry efforts and programs.
- Coordinate NADHM Convocation special events/dedications and programs as designated by the NADHM Chair while working with the Facilitators of Program.

VI. Facilitator of Archives

- Facilitate the collection and preservation of the history of the Association and our community.
- Gather all existing historical material for NADHM (and its previous names). Ask Administrative Office to send all the print history in the office.
- Interview the key players, including those involved in the 1988 General Conference legislation and all of those on the first leadership team.
- Put the history in one readable, user-friendly format so that it can be enlarged as we grow.
- Connect with the Administrative office for digital archive to see how we can coordinate.
- Serve as resource for the community about our history.
- Make materials available at Convocation
- **VII. Executive Secretar(ies)** of the administrative office for the Offices of Deaconess, Home Missioner, and Home Missionary of UMW will coordinate with, assist and resource NADHM in whatever ways possible.

8. Meetings

Members of the Leadership Team shall be reimbursed for reasonable expenses incurred in the performance of their duties, including costs of attending meetings. Since the Leadership Team attends Convocation as a NADHM Member and if scholarships are available through the administrative office, it has been the practice for Team members to pay their own registration and NADHM pay travel. In order for travel to be reimbursed, team members should purchase ticket, advance airfare at least 30 days before travel date, driving mileage or advance air, whichever is less. Team members will be reimbursed for one checked bag. If a team member does not live a reasonable distance from an airport, they may submit for reimbursement and parking.

9. Nominating Committee

There shall be a nominating committee with duties as defined in Bylaws Article 7.


- Get to know the community members' names, their gifts and graces through the roster provided by the Administrative Office and information on Listserve.

- Since nominating committee members serve in a consultant role to the Leadership Team and are not required to attend conference calls and do not attend face to face meetings, they do not receive reimbursement on expenses to Convocation.
